

## SHARP Logger Program -- 2002 Annual Report

### 2002 Program Highlights

- ❖ On January 1, 2002, responsibility for the administration and coordination of Virginia's SHARP Logger training and education program was transferred from the Virginia Forestry Association to the Virginia Tech Forestry Department. The SHARP Logger program effectively became a Virginia Tech Forestry Extension program under the direction of Dr. Bob Shaffer, with funding and program oversight from the Virginia Sustainable Forestry Initiative (SFI) State Committee, and administrative support from the Virginia Forestry Association.
- ❖ Scott Barrett was employed as a Virginia Tech Extension Associate on May 1<sup>st</sup> as the full-time SHARP Logger Program Coordinator, with responsibility for planning/ coordinating training programs and developing/maintaining the Program's extensive database and website [[www.sharplogger.vt.edu](http://www.sharplogger.vt.edu)].
- ❖ 167 "new" SHARP Loggers completed the Core Program in 2002, while 240 loggers failed to complete the 3-year Continuing Education (CE) requirement and lost their SHARP Logger standing, bringing the current number of active Virginia SHARP Loggers to 1,934. These loggers represent 1,328 logging businesses, and produce an estimated 90%+ of Virginia's raw forest products.
- ❖ 1393 SHARP Loggers participated in 80 SHARP Logger CE programs covering 11 different topics in 2002 at locations across the Commonwealth. New CE classes developed in 2002 included *Advanced Harvest Planning*; *Wildlife Management and Endangered Species*; and *Improving Timber Harvesting Efficiency*.
- ❖ At least 85 individuals (volunteers?) directly assisted in the implementation of the SHARP Logger Program in 2002. These individuals came from the forest industry, the logging industry, the insurance industry, the banking industry, State agencies, and forest landowners (please see the listing at the end of this report). **Without their help the Sharp Logger Program could not succeed.** Special thanks goes to Virginia Cooperative Extension District Forestry Agents Adam Downing, Dan Goerlich, and Jim Willis ( 29 SHARP Logger Programs collectively), and Virginia Department of Forestry personnel (24 "BMP Update" programs for SHARP Logger CE credit).
