



SHARP Logger Program -- 2003 Annual Report

2003 Program Highlights

- ❖ 2003 was the second full year that VA Tech Forestry Extension has had responsibility for the administration and coordination of Virginia's SHARP Logger training and education program. Scott Barrett serves as the SHARP Logger program coordinator through Virginia Tech Forestry Extension in Blacksburg. The SHARP Logger program continues to be funded through the Virginia Sustainable Forestry Initiative® (SFI) State Committee, with administrative support from the Virginia Forestry Association. With funding from the VA SFI Committee, SHARP Logger programs continue to be offered free of charge to participants.

- ❖ 142 individuals gained SHARP Logger standing in 2003, while 291 loggers failed to complete the 3-year Continuing Education (CE) requirement and lost their SHARP Logger standing, bringing the current number of active Virginia SHARP Loggers to 1,815. Loggers who have completed the training represent approximately 1300 logging businesses, and produce an estimated 90%+ of Virginia's raw forest products.
- ❖ A total of 945 individuals participated in 52 scheduled programs to earn SHARP Logger credits in 2003. Scheduled SHARP Logger programs were offered on 11 different topics in 2003 at locations across the Commonwealth. New CE classes offered in 2003 included BMP Field programs, Logger Safety Awareness Workshop, Roadway Safety Workshops, Orienteering for loggers, and a Log grading and Merchandising workshop.
- ❖ At least 80 individuals directly assisted in the implementation of the SHARP Logger Program in 2003. These individuals came from the forest products industry, the logging industry, the insurance industry, state agencies, and forest landowners (please see the listing at the end of this report). Together, they represent a contribution to the SHARP Logger program from 9 state agencies and 30 companies and other organizations. Special thanks goes to Virginia Cooperative Extension District Forestry Agents Adam Downing, Dan Goerlich, and Jim Willis for the many SHARP Logger trainings they planned and conducted. **Without the help from everyone involved, the Sharp Logger Program could not succeed.**
