Changes to SHARP Logger Standards

In the April 2021 newsletter (www.sharpllogger.vt.edu/resources.html), we talked about how the Sustainable Forestry Initiative (SFI) had proposed changes to their logger training standards. Those changes have been approved, and we have made some changes to the SHARP Logger Program to meet the new standards.

The biggest shift is from a 3-year renewal cycle to a 2-year cycle. Instead of earning 12 Continuing Education credits every three years, SHARP Loggers will need to earn 8 CE credits every two years to maintain their SHARP status. This change will affect you after your next renewal. For example, if you have an expiration date of 1/1/2022, you will have had 3 years and need 12 credits. But when your status renews on 1/1/2022, you will get a new expiration date of 1/1/2024 (2 years), and need 8 credits by then. It will take 3 years to switch all SHARP Loggers to the new 2-year cycle, so know that some of your coworkers will be on a different schedule than you are. We will keep you informed as these changes begin to affect you. The 3-credit SHARP Logger Update Class will remain a requirement in every renewal cycle.

We are also working on shortening the Core Program. When the new Core Program is ready, it will be two days instead of three. It will also be available as a hybrid class—those who choose to will be able to take part of the class online on-demand. We plan this change to go into effect for new SHARP Loggers in 2022.

Spotted Lanternfly Quarantine

Alert! The Virginia Department of Agriculture and Consumer Services (VDACS) has enacted a quarantine for Spotted Lanternfly (SLF), an invasive insect. The quarantine area currently includes the City of Winchester, Clarke, Frederick, and Warren counties. Before moving regulated items out of the quarantine area they must be free of SLF. Regulated articles include, but are not limited to, all plant parts, packing material, outdoor equipment, and vehicles- essentially anything that has been outside! Businesses can obtain a permit from VDACS to allow them to conduct self inspections. How Many Credits Do I Need?? How Can I Check My Credits??

If you became a SHARP logger before February 2021, then you must earn 12 CE credits every 3 years in order to maintain your SHARP Logger status. That must include the 3-credit, required SHARP Logger Update Class. **The number of CE credits you need is printed above your name on the mailing label.** For example, if you have earned 3 credits so far during your current 3-year cycle, your label will say "You need 9 credits." If the label says "Update Needed" then you have not attended the required SHARP Logger Update Class and need the Update before you can renew. Even if you have more than 12 credits, you must take the Update. The label will also show your expiration date. If it says your credits are due by 1/1/2021 then your SHARP logger status has expired and you must earn the required CE credits by the end of this year or else you will have to retake the Core Program to become a SHARP Logger again. You can also check your credits, Update status, and expiration date on the website (www.sharplogger.vt.edu), by typing your last name (only) in the "check credits" box at the top of the page. If your record does not come up, either you are expired or there is an error. Contact the SHARP Logger Program at sharplogger@vt.edu or 540-231-6494.
