Results of the SHARP Logger Survey

During the summer of 2009, the VA SHARP Logger program mailed a survey to all current SHARP Loggers. Nearly 60 percent of all SHARP Loggers completed and returned that survey to us. I want to express my gratitude to you for doing so. That type of response rate is outstanding and gave us great data to work with. The results will help us to improve the SHARP logger program, to better understand the logging workforce in Virginia, and will help to raise the level of awareness of Virginia Loggers.

Just a few of the results that some of you may find interesting. Of all the survey respondents, 477 indicated they were the owner of a logging business. Of the 477 logging business owners,

- Average age was 48.6 years old
- 86 % were full time logging contractors
- Average weekly production across the entire state was just over 20 loads per week per crew, however this varied by region. Average production in the mountains was 11 loads per week, piedmont loggers averaged about 22 loads per week and in the coastal plain, average production was a little over 32 loads per week.
- The level of mechanized harvesting showed similar differences across regions. In the mountains, 91 percent of loggers reported that the most common way the felled timber was with a chainsaw. Manual chainsaw felling dropped to 36% in the piedmont and only 9% in the coastal plain.
- When asked to rank potential SHARP Logger CE classes in terms of usefulness, the top classes were BMP's for Water Quality, Stream Crossing Options, Chainsaw Safety, and Equipment Safety.

Upcoming Continuing Education (CE) classes

With the new format of this newsletter, we are still working out some of the issues with printing the CE credits you have earned, so please be patient, this may change again in the future. For now, you should notice that the number of CE credits you need is printed right above your name on the mailing label. Please note, this is the number of CE credits that you still need to earn before your renewal date. As a reminder, SHARP loggers must earn 12 CE credits every 3 years in order to maintain their current SHARP logger status. So for example if you have earned 3 credits your label will say "You need 9 More CE credits before January 1, 20XX."

Online Logger Training Update

The last SHARP logger newsletter mentioned our online Continuing Education classes which we now have available. Two classes were developed in cooperation with the VDOF and can be viewed from the SHARP Logger Website. The classes are "Protecting Water Quality with BMP's in Virginia", and "Laws Affecting Water Quality and Forestry Operations in Virginia".

Combined, these classes have been viewed nearly 100 times. SHARP loggers that have completed the classes so far have overwhelmingly indicated that the classes are easy to use, they would like to use online classes again, and have told us that it saves time and money compared to traveling to a class. While we have no intention of replacing "face to face" classes, we do intend to offer more online classes as another option to help SHARP Loggers earn the CE credits they need.

To complete the online classes go to our website at www.sharplogger.vt.edu On the home page, click on "Online Training", then review the instructions and click on the class you would like to view. Each class will count for 1 SHARP Logger CE credit, for SAF Certified Foresters, each class will count for .5 CFE credit. Follow the instructions online to submit for SHARP CE credits. You will need to have your SHARP Logger number to submit for CE credit.

EXPO Richmond 2010 May 21, & May 22 2010

The SHARP logger program will again be offering 3 hours of CE credit for attending the East Coast Sawmill and Logging Equipment Exposition at the Richmond Raceway Complex in Richmond, VA on May 21 & 22. The SHARP logger Booth will be located in the Virginia Tech College of Natural Resources display area and will be **Booth # 74 in the Commonwealth building**. While you are there you can stop and visit with us and other VA Tech Forestry Extension displays, Wood Science and CNR alumni displays as well.

Also note that you will only receive 3 SHARP Logger CE credits, even if you attend both days of the EXPO, so please just sign in once at the SHARP logger display in Booth # 74.
